City Council "Special" Meeting Minutes  
Wednesday, December 9, 2020 5:00 p.m.

The Board of Aldermen met on Monday December 9, 2020 at 5:00 p.m. Mayor Bodi called the meeting to order. Ald. Riley, Ald. Chism, Ald. Cravens, and Ald. White were in attendance. Ald. Keene was not present.
