#### **F. City Administrator's Report**

Mill street water tower- work began April 18<sup>th</sup>. Containment will begin soon, which will be followed by sandblasting and paint.

Alternative Utility Bill payments- Tyler technologies, our current service provider, has a couple of alternative payment methods we will begin utilizing for the June billing period.

Governors cost share- We are close to getting our Governors cost share agreement. Once it is received, we can begin procuring engineers and project design. We are expecting the agreement anytime.

YMCA announcement- The YMCA will be bringing their summer BLAST Day camp to New Madrid. This will be a great program for New Madrid. The program will run M-F June 19-July 28.

DED ARPA Funding- Friday May 5<sup>th</sup> Governor Parsons announced New Madrid will be receiving \$2.5 million from an Industrial Site Development grant program through the American Rescue Plan Act. Once fifteen of these grants were awarded. The funding is to help communities develop sites that are ready to support business expansion.
