CITY COUNCIL MEETING MINUTES
Monday October 28, 2024

CALL TO ORDER

The October 28, 2024, regular meeting of the Board of Alderman of the City of New Madrid was called to order at 6:00pm with Mayor Nick White presiding. Alderman Riley, Alderman Keene, Alderman Cravens, Alderman Chism, Alderman Lawfield and Alderman Henderson were present.

Also in attendance was City Administrator, Aaron Griffin, City Clerk, Paige Keene, and City Finance officer Kristy Taylor.

Alderman Keene led us in prayer.

Mayor White led the Pledge of Allegiance.

A. Approval of minutes

The minutes from September 23, 2024, regular meeting was presented.

MOTION: Alderman Chism made a motion and Alderman Lawfield seconded. All Alderman present voted "Aye." The vote was unanimous **MOTION PASSED.**

B. Visitors

LaKishea Braxton the owner of Heart 2 Help- a sober living recovery treatment facility, came to the council asking to rezone the property behind her current building. She is looking to expand her business and open a 20 room 40 bed facility. The rezoning of the property would be helpful for her process with the bank. The council agrees this would be doable.

C. New Business

Officer Shane Grissom who was earlier appointed to work on code enforcement feels he did not have the time to dedicate to the position. Officer Sisk has shown interest at least temporarily.

MOTION: Alderman Riley made a motion to accept the appointment of Officer Sisk and Alderman Keene seconded. All Alderman present voted "Aye." The vote was unanimous **MOTION PASSED.**

The council took some time to review all current agricultural lease agreements the city has. All contracts are valid until 2028 with exception of the property near the nursing home this lease renews yearly at this time. There is no signed up to date contract for the industrial park land with the current farmer. The council agrees we need more money from this land and Attorney Hunter will write up a new contract and pass it by the end of the month for 3 years to get this land on track with the rest of the property owned.

Finance Officer Kristy Taylor reviewed the basic financials from the 3rd quarter.
