City Council Meeting Minutes

Call to Order

1. Resolution to Award the Bid for the Mowing of the City's Cemeteries
Alderman Keene made a motion and Alderman Lawfield seconded the motion to award the bid to Grass Monkey for the 2025 mowing season in the amount of \$42,930.00. All aldermen present voted "Aye." Motion Passed
2. Resolution to Award the Bid for the Mowing of the City's Parks
Alderman Chism made a motion and Alderman Courtois seconded the motion to award the bid to DeJournett Lawn Care for the 2025 mowing season in the amount of \$51,948.00. All aldermen present voted "Aye." Motion Passed

D. City Administrator's Report

The council discussed the duration of the mowing contract and agreed that starting in 2026 the contracts would each be for three years.

The new substation is nearing completion. Testing should be completed in March and it should go live in April.

The architects met today with Aaron Griffin and Kristy Taylor about the new City Hall. Production drawings should be completed April 21st with the project going out to bid after that.
